- It has been explained to me, and I understand, that my garage door operator may have been strained or worn due to the condition of an unbalanced overhead door. I acknowledge that the technician cannot predict the longevity of the operator, and I understand that no guarantee or warranty is provided for a strained or worn operator.
- I understand that my garage door and door operator are two separate mechanical systems.
- Door estimates do not include trim or openers unless explicitly stated on the estimate or invoice.
- All estimates provided are valid for 14 calendar days from the date of issuance.

Payment Terms

The following payment terms apply to all services authorized under this estimate. By approving the estimate and authorizing work to begin, the Client agrees to adhere to the payment conditions outlined below:

- Payment for services rendered is due upon completion of the job unless otherwise agreed in writing. Late or unpaid balances may be subject to additional charges.
- All door orders require a non-refundable deposit of at least 50% at the time of order. The remaining balance is due in full at the time of installation.
- The final balance must be paid in full upon delivery, regardless of pending items such as touch-up paint, trim, or services not specifically listed in the job estimate.
- Any check returned due to non-sufficient funds (NSF) will be subject to a \$15 NSF fee in addition to the outstanding balance.

Remaining Payment & On-File Card Addendum

- For door and parts installation projects, SGD retains the right to charge the remaining balance to the same card used for the down payment within 48 hours of confirmed completion of the final door installation. This policy is in place because all door installations require a non-refundable deposit, and the card used for that deposit is securely held on file to ensure timely and accurate final payment processing.
- By paying a deposit for a door or parts installation project, or by signing this estimate, the Client agrees to pay the remaining balance in full upon completion.
